The Government of Nepal [GoN] **has allocated funds or received a loan/credit/grant** from [GoN] towards the cost of **following projects** and intends to apply part of the funds to cover eligible payments under the Contract **for DROCHT/33701138/076/77-023,024**. Bidding is open to all eligible as per Section V of bidding document.
2. **Road Division Charikot** invites sealed bids or electronic bids from eligible bidders for the construction of **following works¹** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the PPMO e-GP system www.bolpatra.gov.np/egp.
5. Bidder has the option of electronic bidding only and to submit their bid may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

6. Pre-bid meeting shall be held at **Road Division Charikot** at **15th October, 2019**.²
7. Electronic bids must be submitted to the office through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00hrs** on **24th October, 2019**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hrs** on **24th October, 2019** at the office. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **as mentioned in the table above**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
