5. Electronic bids must be submitted to the office **Road Division Chaurjahari, Rukum West** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 Hrs** on **2083-05-09 (25 August, 2026)**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 Hrs on 2083-05-09 (25 August, 2026)** at the office of **Road Division Chaurjahari, Rukum West**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **as mentioned in above table**, which shall be valid for 30 days beyond the validity period of the bid.
