1. **The Heavy Equipment Division, Kathmandu** invites hardcopy bids from eligible bidders for “**RE-The Procurement of Maintenance Service of Light Vehicles**” under National competitive bidding – Single Stage Single Envelope procedures.

3. Bidding document will be provided from the office on or before **7th September 2026 (2083/05/22nd)** for bidding after providing the bid documents fee voucher along with letter and other documents within office hour.
4. Pre-bid meeting shall be held at **Heavy Equipment Division, Kathmandu at 13:00PM on 3rd September 2026 (2083-05-18)**
5. Bids must be submitted through hardcopy on or before **12:00PM on 8th September 2026 (23rd Bhadra 2083)**. Bids received after this deadline will be rejected.
6. Bidding document will be provided on or before **8th September 2026 (23rd Bhadra 2083)** for hardcopy submission. The bidder shall be required to deposit the non-refundable fee of **NRs 3000** in the Revenue (Rajaswa) account as specified below and Bank Deposit voucher shall be provided to collect the bid documents.

The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00PM on 8th September 2026 (23rd Bhadra 2083)** at the office of **Heavy Equipment Division, Kathmandu**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security of scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. **1,20,000.00 (In Words, One Lakhs Twenty Thousand Only)**, which shall be valid for 30 days beyond the validity period.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
