1. Department of Roads (DOR) invites bids from eligible bidders for the procurement of **Supply, Delivery and Procurement of Miscellaneous Items in Department of Roads under National Competitive Bidding (NCB) procedures.**
2. Eligible Bidders may obtain further information and inspect the bidding documents at the office of Department of Roads, Central Store, Chakupat, Lalitpur or may visit PPMO egp system www.bolpatra.gov.np/egp.
3. A complete set of Bidding Documents may be purchased from the office Department of Roads, Central Store, Chakupat Lalitpur by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs 3000/- till 2nd November 2020 (17th kartik 2077) during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below .

5. Sealed or electronic bids must be submitted to Department of Roads, Central Store, Chakupat, Lalitpur hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 hours on 3rd November, 2020 (18th kartik 2077). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 Hours on 3rd November, 2020 (18th kartik 2077) at the office of Department of Roads, Chakupat, Lalitpur. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 84,000/-, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
