5. Pre-bid meeting shall be held at Department of Roads, Bridge Branch at 28th March, 2024.
6. Electronic bids must be submitted to the office Department of Roads, Bridge Branch through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12th April, 13:00** hrs. Bids received after this deadline will be rejected.
7. Bids shall be opened in presence of Bidders' representatives who choose to attend on www.bolpatra.gov.np/egp on or before 12th April, 14:00 hrs at the office of Department of Roads, Bridge Branch. Bids must be valid until 12th July, 2024 and must be accompanied by bid security, amounting to a minimum of NRs. 75,000, which shall be valid for minimum 30 days beyond the bid validity period 11th August, 2024.
8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
