**EXPRESSION OF INTEREST FOR CONSULTING SERVICES**

1. The Government of Nepal, Department of Roads, Madan Bhandari Highway Project Directorate, invites Expressions of Interest (EOI) for the purpose of short listing of the qualified, eligible and experienced domestic consulting firms for the **Detailed Engineering Survey, Design of Road, Report Preparation (DPR) and Initial Environmental Examination (IEE) of Baddichour-Gutu-Simchour Section of Madan Bhandari Rajmarga** under contract number **MBHPD/3371254/075/76/DPR-04**. The Standard EOI forms and EOI Evaluation Criteria can be downloaded from [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). The budget to this purpose has been allocated by the Government of Nepal (GON) for the fiscal year 2075/076.
2. Experienced, eligible and willing Consulting Firms are invited to submit their EOI, either single or in joint venture with other firms. The firm/JV shall submit EOI through PPMO's EGP system, [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **17:00, 2076-01-12 BS (2019-04-25 AD)**. Hard copy shall not be entertained during submission of EOI. The submitted EOIs shall be opened electronically in the presence of Consultants' representatives who choose to attend on **2076-01-13 BS (2019-04-26 AD), 11:00** at Department of Roads, Madan Bhandari Highway Project Directorate, Chakupat, Lalitpur.
3. Consulting Firms can form a Joint Venture (JV) with maximum 3 no. of firms. The EOI documents must clearly mention the name of the leading firm with financial liabilities. Authorized power of attorney shall be submitted along with EOI document.
4. Minimum score to pass the EOI is 60% of full marks. Top Six Short listed consultants will be invited to submit their Technical and Financial Proposal as per the Request for Proposal (RFP), to be provided to them at the later stage. Madan Bhandari Highway Project Directorate, DoR reserves the right to shortlist any or all of the Firms without assigning any reasons whatsoever. Further information or clarification can be obtained from Directorate, DoR during office hours.
5. The submitted EOI document shall include adequate information as per the evaluation criteria/EOI forms to demonstrate their qualification in the best manner.
6. Hard copy of electronically submitted EOI documents shall be submitted to DoR, Madan Bhandari Highway Project Directorate within 3 days from last date of EOI submission.
