

## Grievance Record and Resolution Status

November, 2019

At project level, a grievance redress mechanism has been established to allow project affected persons to appeal any disagreeable decisions, practices and activities arising in the process of compensation for assets and general project-related complaints. Grievance recording register has been established at PIC/RE/Contractor's Offices. The total 26 grievances from January 2017 to November 2019 were registered. Among them 19 grievances were resolved and 4 grievances are in resolution process and 3 grievances are not applicable. The recorded grievances and their status have been given below:
