1. **Road Division Nuwakot** invites sealed bids or electronic bids from eligible bidders for the construction of **Upgrading/Improvement works of Dhadingbesi Tipling Road (Baikailpik Rajmarga) Sima Naka Rasuwagadhi dekhi Prithvi Rajmarga jodne Baikailpik Rajmarga (1.15 Km.), Dhading** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRS 86.00 million**
- Minimum Work experience of similar size and nature:
One Partner : One Contract of Road work with value at least NRS. 17.00 Million
Each Partner : One Contract of Road work with value at least NRS. 4.00 Million

2. Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at PPMO e-GP system www.bolpatra.gov.np/cgp.
4. Bidders who choose to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/cgp at no cost.
5. Pre-bid meeting shall be held at **Road Division, Nuwakot at 13:00 PM on 2083/04/25.**
6. Electronic bids must be submitted to the office **Road Division Nuwakot** through PPMO's e-GP system www.bolpatra.gov.np/cgp on or before **Time 12: 00 Noon on 2083/05/08**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **Time 13: 00 PM on 2083/05/08** at the office of **Road Division Nuwakot**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **1.00 Million** which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
