4. Pre-bid meeting shall be held at *Road Division Sanfebagar, Achham* at **13:00 hrs** on **2083-04-22 (A.D. 2026-08-07)**.
5. Electronic bids must be submitted to through PPMO website www.bolpatra.gov.np/egp on or before **12:00 hrs** on **2083-05-03 (A.D. 2026-08-19)**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hrs** on **2083-05-03 (A.D. 2026-08-19)** at the office of *Road Division Sanfebagar, Achham*. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **as mentioned in above table**, which shall be valid for 30 days beyond the validity period of the bid.
