1. *The Government of Nepal [GoN], North-South (Koshi) Road Project, Sankhuwasabha has allocated funds from GoN towards the cost of Road assets protection, restoration of damaged public utilities and road demarcation with monument installation etc. from Loving-Hill to Chyangkuti and intends to apply part of the funds to cover eligible payments under the Contract for NSKRP/337011184/083/84-01. Bidding is open to all eligible as per Section V of bidding document.*
2. *North-South (Koshi) Road Project, Sankhuwasabha invites sealed bids or electronic bids from eligible bidders for the construction of Road assets protection, restoration of damaged public utilities and road demarcation with monument installation etc. from Loving-Hill to Chyangkuti under National Competitive Bidding (NCB) – Single Stage Two Envelope Bidding procedures.*

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 61 million**
- Minimum Work experience of similar size and nature: **(a) For Single Entity, One Road Project with Contract Value of at least NRs. 16 million within last 10 years b) For JV, one Road Project of value at least NRs. 16 million for One Partner within last 10 years**

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Or

Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

*Project, Sankhuwasabha* and the office *North-South (Koshi) Road Project, Sankhuwasabha* by eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of **NRs. 5,000** till **15th September, 2026 (30th of Bhadra, 2083)** during office hours in the account as specified below.

6. Pre-bid meeting shall be held at **North-South (Koshi) Road Project Office, Khandbari** at **27<sup>th</sup> August, 2026**
7. Sealed or electronic bids must be submitted to the office through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00PM** on **16<sup>th</sup> September, 2026 (31<sup>st</sup> of Bhadra, 2083)**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00PM on 16<sup>th</sup> September, 2026 (31<sup>st</sup> of Bhadra, 2083)** at the office of **North-South (Koshi) Road Project, Sankhuwasabha**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 1 million** which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
